✓ Under Age three

For infants and toddlers age birth to 36 months:

**Please call: (916) 978-6249**

✓ Over Age Three

For children over the age of three through adulthood:

**Please call: (916) 978-6317**

*Individuals can be referred to ACRC at any age. For those age 18 and older at the time of the referral, the assessment must determine that the eligible condition began before their 18<sup>th</sup> birthday to qualify for regional center services.*

## What is Alta California Regional Center (ACRC)?

ACRC is a private non-profit corporation working under contract with the California Department of Developmental Services (DDS) to assist people with developmental disabilities, children at risk of developing a developmental disability and their families, to achieve healthy and productive lives in their own community.

ACRC is the one agency in the community through which people with qualifying conditions, and their families, are assisted to make use of essential public and private services to meet their unique needs.

Alta California Regional Center is one of a network of 21 regional centers in California established by the Lanterman Mental Retardation Services Act of 1969.

## Who is eligible?

Residents of Alpine, Colusa, El Dorado, Nevada, Placer, Sacramento, Sierra, Sutter, Yolo and Yuba Counties can be assessed for eligibility.

### The Early Start Program (Birth to 36 months)

If you have any concerns about a child's development, please make a referral for a developmental assessment.

### Eligibility under the Lanterman Act (Age three and older)

Regional Center eligibility for persons age three and older is established through assessment and diagnosis performed by ACRC. Conditions of eligibility:

- Intellectual disability (ID)
- Cerebral palsy (CP)
- Epilepsy
- Autism (ASD)
- Or other handicapping conditions found to be closely related to intellectual disability or to require similar treatment

In addition, the disability must begin before the age of 18, continue or be expected to continue indefinitely, and constitute a substantial handicap for such individuals.

## What services can ACRC provide?

- Genetic counseling referral
- Developmental Assessment to provide Early Intervention services for infants
- Assessment and Diagnosis for individuals over the age of three
- Individualized Planning
- Service Coordination
- Information and referrals
- Purchasing necessary services

## How much do services cost?

Assessment to determine eligibility is provided free of charge. If found eligible, case management to develop an individual program plan (IPP) is also free of charge.

For some parents of children under age 18, there may be a share of cost for some services or a family fee of up to \$200 per year based on family size and income. If any of these fees apply to your family, your Service Coordinator will provide more information about the Parental Fee Program, the Family Cost Participation Program and/or the Annual Family Program Fee, as necessary.
