Family members residing in Mexico cannot receive plan benefits from California providers, except for emergencies, which are covered worldwide.

²SIMNSA members can pay a discounted price of \$15.00 for a medical pass at SIMNSA clinics with an appointment for medical services, or lab appointment which were rendered at the clinic. SIMNSA members have 48 hours to use the pass to cross the international border. SIMNSA may only issue one per subscriber or per family. There is no limit to the amount of passes members may receive and is subject to availability.
