## **Description**

Tolvaptan (Jynarque®, Samsca®) is a selective vasopressin V2-receptor antagonist.

# FDA Approved Indication(s)

Jynarque is indicated to slow kidney function decline in adults at risk of rapidly progressing autosomal dominant polycystic kidney disease (ADPKD).

Samsca is indicated for the treatment of clinically significant hypervolemic and euvolemic hyponatremia [serum sodium < 125 mEq/L or less marked hyponatremia that is symptomatic and has resisted correction with fluid restriction], including patients with heart failure and syndrome of inappropriate antidiuretic hormone (SIADH).

### Limitation(s) of use:

- Patients requiring intervention to raise serum sodium urgently to prevent or to treat serious neurological symptoms should not be treated with Samsca.
- It has not been established that Samsca provides a symptomatic benefit to patients.

#### Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation<sup>®</sup> that Jynarque and Samsca are **medically necessary** when the following criteria are met:

#### I. Initial Approval Criteria

# A. Autosomal Dominant Polycystic Kidney Disease (must meet all):

- 1. Diagnosis of ADPKD;
- 2. Request is for Jynarque;
- 3. Prescribed by or in consultation with a nephrologist;
- 4. Age  $\geq$  18 years;
- 5. Dose does not exceed 120 mg/day.

#### **Approval duration:**

**Medicaid/HIM** – 12 months

Commercial – Length of Benefit

## **B.** Hyponatremia (must meet all):

- 1. Diagnosis of hypervolemic or euvolemic hyponatremia;
- 2. Request is for Samsca;
- 3. Prescribed by or in consultation with a nephrologist, cardiologist, or endocrinologist;
- 4. Recent (within the last 7 days) serum sodium level < 125 mEq/L, unless hyponatremia is symptomatic and has resisted correction with fluid restriction;
- 5. Age  $\geq$  18 years;
- 6. Dose does not exceed 60 mg per day.

Approval duration: 30 days

## C. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

# **II. Continued Therapy**

# A. Autosomal Dominant Polycystic Kidney Disease (must meet all):

- 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
- 2. Member is responding positively to therapy;
- 3. If request is for a dose increase, new dose does not exceed 120 mg/day.

# **Approval duration:**

**Medicaid/HIM** – 12 months

Commercial – Length of Benefit

#### **B.** Hyponatremia (must meet all):

- 1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
- 2. Member is responding positively to therapy as evidenced by increased sodium level since baseline;
- 3. If request is for a dose increase, new dose does not exceed 60 mg/day.

#### Approval duration: up to a total duration of 30 days

#### C. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

## Approval duration: Duration of request or 12 months; or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid.

## III. Diagnoses/Indications for which coverage is NOT authorized:

**A.** Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies –



CP.CPA.09 for commercial, HIM.PHAR.21 for health insurance marketplace, and CP.PMN.53 for Medicaid or evidence of coverage documents

Appendix C: Contraindications/Boxed Warnings

- Contraindication(s):
  - o Jynarque:
    - History, signs or symptoms of significant liver impairment or injury, does not include uncomplicated polycystic liver disease
    - Concomitant use of strong CYP 3A inhibitors is contraindicated
    - Uncorrected abnormal blood sodium concentrations
    - Unable to sense or respond to thirst
    - Hypovolemia
    - Uncorrected urinary outflow obstruction
    - Anuria
  - o Samsca:
    - Use in patients with ADPKD outside of FDA-Approved REMS
    - Need to raise serum sodium acutely
    - Patients who are unable to respond appropriately to thirst
    - Hypovolemic hyponatremia
    - Concomitant use of strong CYP 3A inhibitors
    - Anuria
    - Hypersensitivity
- Boxed warning(s):
  - o Jynarque: risk of serious liver injury
  - o Samsca:
    - Initiate and re-initiate in a hospital and monitor serum sodium
    - Not for use for ADPKD

Tolvaptan (Samsca)	hyponatremia	The target dose is 120 mg/day (90 mg in the morning and 30 mg 8 hours later), if tolerated.  15 mg PO QD, then 30 mg PO QD after 24 hours, to a maximum of 60 mg PO QD as needed to achieve the desired level of serum sodium.	60 mg/day
		Do not administer Samsca for more than 30 days to minimize the risk of liver injury.
