Description

Cemiplimab-rwlc (Libtayo[®]) is a programmed death receptor-1 (PD-1) blocking antibody.

FDA Approved Indication(s)

Libtayo is indicated for the treatment of patients with metastatic cutaneous squamous cell carcinoma (CSCC) or locally advanced CSCC who are not candidates for curative surgery or curative radiation.

Policy/Criteria

Provider must submit documentation (such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Libtayo is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Cutaneous Squamous Cell Carcinoma (must meet all):

- 1. Diagnosis of CSCC;
- 2. Disease is metastatic or locally advanced;
- 3. Prescribed by or in consultation with an oncologist;
- 4. Age \geq 18 years;
- 5. Member is not a candidate for curative surgery or curative radiation;
- 6. Request meets one of the following (a or b):*
 - a. Dose does not exceed 350 mg (1 vial) every 3 weeks;
 - b. Dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
 *Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration:

Medicaid/HIM – 6 months

Commercial – 6 months or to the member's renewal date, whichever is longer

B. Other diagnoses/indications

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial and CP.PMN.53 for Medicaid and HIM-Medical Benefit.



II. Continued Therapy

- A. Cutaneous Squamous Cell Carcinoma (must meet all):
 - 1. Currently receiving medication via Centene benefit, or documentation supports that member is currently receiving Libtayo for a covered indication and has received this medication for at least 30 days;
 - 2. Member is responding positively to therapy;
 - 3. If request is for a dose increase, request meets one of the following (a or b):*
 - a. New dose does not exceed 350 mg (1 vial) every 3 weeks;
 - b. New dose is supported by practice guidelines or peer-reviewed literature for the relevant off-label use (*prescriber must submit supporting evidence*).
 *Prescribed regimen must be FDA-approved or recommended by NCCN

Approval duration:

Medicaid/HIM - 12 months

Commercial - 6 months or to the member's renewal date, whichever is longer

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 6 months (whichever is less); or

 Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.CPA.09 for commercial and CP.PMN.53 for Medicaid and HIM-Medical Benefit.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.CPA.09 for commercial and CP.PMN.53 for Medicaid and HIM-Medical Benefit or evidence of coverage documents.
