# 2026 Medicare Advantage Updates: What Providers Need to Know

# County changes, plan terminations and member impacts

**Starting January 1, 2026**, important changes to Medicare Advantage (MA) plans will take effect. This guide outlines county-specific plan transitions, terminations and benefit updates to help providers stay informed and support affected members.

# County-level plan transitions and terminations

### Plan termination - Full plan discontinuation

The following MA plan will be fully terminated:

- Wellcare Simple (HMO) H5087-016
  - Affected counties: Riverside and San Bernardino
  - Effective date: December 31, 2025

#### **Provider impact:**

- Members will be disenrolled from the plan.
- Notification letters were mailed to members in early October outlining their Medicare options.

#### Segmented plan adjustments

#### Administrative segmentation of Wellcare Simple (HMO)

The current plan *H5087-024* will be segmented into two separate plans based on county:

• San Joaquin: H5087-034-001

Ventura: H5087-034-002

# **Provider impact:**

- This segmentation is for administrative purposes only.
- No changes to network participation or reimbursement terms.
- Members will receive new ID cards.
- Updated eligibility files will reflect new member assignments.
