

Enhanced Care Management Program Populations of Focus Screening Checklist

The Enhanced Care Management (ECM) Program provides comprehensive care management services to seven different Populations of Focus with a goal to improve the health and social outcomes of the ECM-enrolled member.

Medi-Cal managed care members are eligible for the ECM Program if they meet the ECM Populations of Focus eligibility criteria as defined in this checklist **and** are not enrolled in duplicative services (as defined in the *Exclusionary Screening Checklist*).

There are three steps to the screening and referral process:

- 1. **First, complete this** *Populations of Focus Screening Checklist* to determine member **eligibility** as qualifying under one or more of the Populations of Focus.
- 2. Next, complete the *Exclusionary Screening Checklist* to further verify member eligibility.
- 3. If the member is determined to be eligible for ECM based on both screening checklists, complete the ECM Program Member Referral Form and send secure fax (Fax Number: 800-743-1655) to the member's Health Plan for review.

Both screening checklists and the *ECM Program Member Referral Form* can be used as resources and references to support the enrollment and engagement process.

¹The Department of Health Care Services (DHCS) defines homelessness as one of the following:

- An individual or family who lacks adequate nighttime residence.
- An individual or family with a primary residence that is a public or private place not designed for or ordinarily used for habitation.
- An individual or family living in a shelter.
- An individual exiting an institution to homelessness.
- An individual or family who will imminently lose housing in next 30 days.
- Unaccompanied youth and homeless families and children and youth defined as homeless under other Federal statutes.
- Victims fleeing domestic violence.

If **ALL** boxes above are checked, member is eligible.
