SIGN UP FOR A WEBINAR TO SEE WHAT'S CHANGING JANUARY 1, 2023

As a reminder, on January 1, 2023, members enrolled in Cal MediConnect (Medicare-Medicaid Plan) or a dual eligible Special Needs Plan (D-SNP) "look alike" will transition to another plan as applicable. This change will help create an integrated approach to care coordination and provide extra support and resources to patients.
