

Health Net Q&A for Providence Participation Agreement Termination

Background

Providence Health & Services sent Health Net notice of termination of its contract with Health Net for services provided on or after January 1, 2013. Providence Health & Services is a statewide health system comprised of eight (8) hospitals and multiple medical groups.

Health Net has been able to reach an agreement with Providence Medford Medical Clinic in Jackson County. Providence Medford Medical Clinic is contracted to continue to be an in-network provider for Health Net in 2013, including Medicare Advantage plans. Additionally, the Providence Medical Group Physicians in Jackson County is contracted to remain in-network for 2013.

Q: Why will Providence no longer be a participating provider?

A: Providence sent Health Net notice of termination of its contract with Health Net. Our understanding is that the termination is part of Providence's business strategy. Health Net continues to have a robust network and provider partnerships that will give you access to quality, affordable care. Health Net has been able to reach an agreement with Providence Medford Medical Clinic in Jackson County. Providence Medford Medical Clinic is contracted to continue to be an in-network provider for Health Net in 2013, including Medicare Advantage plans. Additionally, the Providence Medical Group Physicians in Jackson County is contracted to remain in-network for 2013.

Q: When is the termination effective?

A: The contract relationship will end December 31, 2012. From January 1, 2013, Providence will no longer be a participating provider for any Health Net benefit plan. Health Net members who receive care at Providence may continue to be covered at out-of-network rates if their benefit plan includes an out-of-network benefit feature. Members are encouraged to check their plan documents for a description of their benefits. Prior authorization requirements apply per the terms of your plan.

Q: I'm a member. Is there anything I have to do?

A: In order to continue to receive the highest level of benefits on or after January 1, 2013, members should utilize a Health Net participating provider. Health Net members who receive care at Providence may continue to be covered at out-of-network benefits if their benefit plan includes an out-of-network benefit feature. Members are encouraged to check their plan documents for a description of their benefits. Prior authorization requirements apply per the terms of your plan.

Q: What products does this termination impact?

A: This termination applies primarily to the PPO line of business, but it does include Commercial EPO/POS and Medicare PPO products at select locations (See **tables**). For Health Net Medicare Advantage PPO plans, Providence providers that are included in the termination notice will no longer be offered as an in-network option starting on January 1, 2013. Medicare Advantage HMO plans are not affected by this termination notice.

*If you are unsure which product you are enrolled in, please refer to your membership card.



Q: How will Health Net members who use Providence for care be notified of this development?

A: Health Net has mailed letters to all Commercial members who visited an affected Providence provider or facility two or more times within the last two years while also insured with Health Net. Members may also receive communications from Providence.

Q: How is Health Net handling costs associated with continued access to care needs for PPO Commercial group members?

A1: In an effort to mitigate out-of-network costs for members currently seeking care with Providence physicians or facilities, Health Net of Oregon will provide transitional benefits for the first guarter of 2013.

Although Providence will be an out-of-network provider effective January 1, 2013, any covered services your Health Net PPO, POS or CommunityCare 3T clients receive from a Providence provider between January 1, 2013, and March 31, 2013, will be paid at the member's in-network cost-share and at the greater of the Providence 2012 contract rates or Health Net's Maximum Allowable Amount (MAA).

While Health Net is increasing its coverage during this 90-day transitional period, Providence Health & Services providers affected by the termination will be out-of-network and balance billing may apply.

After March 31, 2013, care obtained through Providence Health & Services will be subject to the out-of-network benefit structure. Again, we will work with members to facilitate transfer of care to in-network providers where appropriate.

Q. How can I tell if my provider is part of the Providence termination, or how do I find another provider that will be contracted from January 1, 2013?

A. The HNOR web-based Provider Directory for Commercial PPO and Commercial HMO network can search for currently participating providers and separately for providers who will be effective as of January 1, 2013. This future effective date option will display participating providers as of January 1, 2013.

Q: Which Providence Facilities, Clinics or Medical Groups does this termination affect?
