

Clinical Policy: Gentamicin Sulfate Injection

Description

Gentamicin sulfate injection is a sterile, nonpyrogenic solution of gentamicin sulfate in water for injection.

FDA approved indication

Gentamicin sulfate injection is indicated for the treatment of serious infections caused by susceptible strains of the following microorganisms: *Pseudomonas aeruginosa*, *Proteus* species (indole-positive and indole-negative), *Escherichia coli*, *Klebsiella-Enterobacter-Serratia* species, *Citrobacter* species, and *Staphylococcus* species (coagulase-positive and coagulase-negative).

Policy/Criteria

Provider must submit documentation (which may include office chart notes and lab results) supporting that member has met all approval criteria

It is the policy of health plans affiliated with Centene Corporation® that Gentamicin sulfate injection is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. Serious Infection (must meet all):

1. Diagnosis of a serious infection caused by susceptible strains of at least one of the following microorganisms: *Pseudomonas aeruginosa*, *Proteus* species (indole-positive and indole-negative), *Escherichia coli*, *Klebsiella-Enterobacter-Serratia* species, *Citrobacter* species, or *Staphylococcus* species (coagulase-positive and coagulase-negative);
2. Member was discharged from an acute care hospital;
3. Intravenous therapy with gentamicin sulfate was started prior to discharge.

Approval duration: Length of benefit

B. Other diagnoses/indications

1. Refer to CP.PMN.53 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

II. Continued Therapy

A. Serious Infection (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;

2. Member is responding positively to therapy [examples: labs, sign/symptom reduction, no disease progression, no significant toxicity, etc].

Approval duration: Length of benefit

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to CP.PMN.53 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policy – CP.PMN.53 or evidence of coverage documents.

Indication	Dosing Regimen	Maximum Dose
Serious infection	5 mg/kg/day IV/IM in 3 or 4 equally divided doses; reduce dose to 3 mg/kg/day as soon as clinically indicated	5 mg/kg
