Description

Methotrexate Oral Solution (Xatmep™) is a folate analog metabolic inhibitor.

FDA approved indication

Xatmep is indicated:

- For the treatment of pediatric patients with acute lymphoblastic leukemia (ALL) as a component of a combination chemotherapy maintenance regimen
- For the management of pediatric patients with active polyarticular juvenile idiopathic arthritis (pJIA) who are intolerant of or had an inadequate response to first-line therapy

Policy/Criteria

Provider must submit documentation (which may include office chart notes and lab results) supporting that member has met all approval criteria

It is the policy of health plans affiliated with Centene Corporation® that Xatmep is **medically necessary** when the following criteria are met:

I. Initial Approval Criteria

A. All Medically Accepted Indications (must meet all):

1. Less than 18 years of age;
2. For ALL: prescribed by or in consultation with an oncologist;
3. For pJIA: prescribed by or in consultation with a rheumatologist;
4. Medical justification as to why member cannot use methotrexate tablets;
5. Dose does not exceed 30 mg/m²/week.

Approval duration: 12 months

B. Other diagnoses/indications

1. Refer to CP. PMN.53 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

II. Continued Therapy

A. All Medically Accepted Indications (must meet all):

1. Currently receiving medication via Centene benefit or member has previously met initial approval criteria;
2. Member is responding positively to therapy (e.g., no significant toxicity);
3. If request is for a dose increase, new dose does not exceed 30 mg/m²/week.

Approval duration: 12 months

B. Other diagnoses/indications(must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request or 12 months (whichever is less); or

2. Refer to CP. PMN.53 if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized).

III. Diagnoses/Indications for which coverage is NOT authorized:

- A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off-label use policy – CP. PMN.53 or evidence of coverage documents.
