In addition, members have access to the Silver&Fit® program provided by American Specialty Health Fitness, Inc. (ASH Fitness), a subsidiary of American Specialty Health Incorporated (ASH).

- Initial examination, subsequent office visits, re-examination

There is a \$50 annual chiropractic appliance allowance toward the purchase of medically necessary items such as supports, collars, pillows, heel lifts, ice packs, cushions, orthotics, rib belts, and home traction units.

## *Chiropractic care*

You may obtain chiropractic care by selecting a participating chiropractor from the ASH Plans network. Although you're always welcome to consult your primary care physician, you won't need a referral to see an ASH Plans network participating chiropractor.

## *What's covered*

### **Office visits**

- \$10 copayment per visit/30 medically necessary visits per calendar year

### **Covered conditions**

- Neurological conditions
- Inflammatory disorders
- Sprain/strain injuries to the spine and extremities
- Intervertebral disc injuries/disorders
- Degenerative joint diseases/arthropathies
- Headaches
- Muscular spasms and myalgias

### *Helpful information*

Services or supplies excluded under the chiropractic care program may be covered under the medical benefits portion of your plan. Consult your plan's *Evidence of Coverage* for more information.

### *Limitations and exclusions*

- Air conditioners, air purifiers, therapeutic mattresses, vitamins, minerals, nutritional supplements, durable medical equipment, appliances, or comfort items.
- Adjunctive physical therapy not associated with spinal, muscle or joint adjustment.
- Diagnostic scanning, MRI, CAT scans, or thermography.
- Exams or treatment of strictly non-musculoskeletal and related disorders.
- Hypnotherapy, behavioral training, sleep therapy, weight programs, educational programs, non-medical self-help or self-care, or any self-help physical exercise training.
- Lab tests, X-rays, spinal or extremity manipulations, physical therapy, or other services not considered medically necessary or classified as experimental.
- Pre-employment physicals or vocational rehabilitation arising from employment or covered under any public liability insurance.
- Treatment for temporomandibular joint syndrome (TMJ).
- Treatment or services not verified as being medically necessary by ASH Plans or delivered by an ASH Plans chiropractor (except emergency chiropractic services or upon a referral to a nonparticipating chiropractor approved by ASH Plans).
